Grampian Health Protection Team (HPT) Weekly Bulletin – Care Homes Week beginning 10/05/21

Symptomatic staff or their household contacts

- Reminder to advise all staff DO NOT ATTEND WORK if have any low grade extended symptoms for example:- headache, runny nose, sinus symptoms, vomiting or diarrhoea, general cold symptoms, sore throat, generally feeling unwell, (off colour) raised temperature. Unfortunately we are still having staff turn up to work then test POSITIVE to Covid 19.
- Please ensure symptomatic staff are aware to book via NHS Grampian and that any household contacts of health and care staff with COVID 19 symptoms should be tested via this route also. https://www.nhsgrampian.org/covid-19/information-for-nhs-grampian-staff/subpages/covid-19-testing/staff-covid-19-testing/

Notification of symptomatic staff or residents - please notify HPT, via duty call room, if any service users or staff are symptomatic and/or being tested.

National hub staff surveillance PCR testing -

- If a result comes back inconclusive staff should simply re-join the following week's surveillance testing. Please advise staff of this and so long as the staff member remains asymptomatic there is NO requirement for the staff member to be retested by another route, other than their LFD tests, in the interim.
- Leaking sample tubes -Labs report that if all samples are placed into the same bag they can leak in transit and contaminate other samples and obscure labels invalidating results. To this end please ensure individual sample tubes are double bagged.

Local guidance from Health Protection Regarding staff who work in care homes and want to **take on a second job** for example pubs, restaurants, retail, hospital and university placements, schools.

- Ultimately the provider, care home manager and the individual have the
 responsibility to make this decision. The care home managers need to have robust
 individual risk assessment in place for that individual whilst ensuring communication
 is maintained to enable escalation and management of any potential threats such as
 a positive case or an outbreak within the 2nd work place of work—it's all about
 minimising the risks of potential transmission within the Care environment
- Care home managers have to ensure that the second work environment has excellent
 mitigating factors in place, such as hand hygiene, mask wearing, and policing social
 distancing. The care home manager also has to be assured the individual will follow
 the guidelines, pertinent to that setting.

Move to level 2 on May 17th – Following the first minister's announcement this week many of you have had questions around to what extent further relaxations for the general population can be applied to both elderly care home residents and people in other care settings?

HPT await further clarity and guidance from both HP Scotland and the Care Inspectorate and until we get further clarity we do not recommend allowing further relaxations to what we have said in previous meetings/bulletins. Care home managers and co-ordinators from other care settings report fielding a lot of questions and receiving a fair amount of pressure from same to allow them to take residents out to indoor public places, overnight stays and trips out of the care environment to visit other friends and relatives in their private dwellings both indoors and outdoors. HPT re-iterated that we should take pace with further relaxations, that each outing should be risk assessed, and the care and safety of residents, staff and visitors should not be compromised or judged as putting any one at risk whilst out and about.
